Director Responsibilities

As a Director of the Club, you will:

- Uphold and promote the values and vision of Ryde-Eastwood Leagues Club.
- Participate in effective governance and strategic decision-making.
- Contribute to providing feedback in policy oversight, financial and risk management.
- Ensure the Club's compliance with legal, regulatory, and constitutional obligations.
- Attend and actively contribute to regular Board meetings and subcommittees.

This voluntary position plays a critical role in maintaining the Club's reputation, community relevance, and continued success.

Eligibility Criteria

As outlined in the Club's Constitution, applicants must:

- 1. Be a **Life Member, financial Foundation Member, or financial Club Member** with at least **five (5) years standing as a Full Member** as at the date of appointment (Rule 65(a)).
- 2. **Not be under suspension**, insolvent, or otherwise disqualified under the Corporations Act or Registered Clubs Act (Rule 69).
- 3. Satisfy character and integrity standards, including:
 - o No convictions for an indictable offence on indictment.
 - o No disqualifying disciplinary matters within the last five years.
 - Not a former employee dismissed for misconduct (Rule 65(f)).

The Board will make this **appointment in accordance with Rule 70** of the Constitution, which provides that the Board may appoint any eligible member to fill a casual vacancy. The appointee will hold office until the conclusion of the next Annual General Meeting in a year in which a Board election is due.

How to Apply

Expressions of Interest must include the following:

1. Cover Letter

- o Outline your interest in the Director role and alignment with the Club's vision.
- Summarise relevant experience in leadership, governance, or community service. Outline their personal involvement in the club activities over time and local community.
- Outline where you feel your expertise and drive can contribute towards working with and being part of the collective board as well as how you feel you would be most appropriate to take up the casual position on the board

2. Statutory Declaration

 A declaration confirming your eligibility under the Constitution and the law, and your agreement to comply with the Club's Board Charter and Code of Conduct.

3. Training Acknowledgement

o Confirm your willingness to undertake Director induction training as required

4. Curriculum Vitae (CV)

 Include professional background, governance experience (if any), qualifications, and current and past Club involvement.
